Id. 19 In the present case, there was no inconsistency because, although Green asserted at trial that he was not injured on the Service Road (and none of his witnesses asserted that he was), the written report attached to the bill of lading, and also the form filled out by James Rutledge (Green's employer) the day after the accident, stated that Green was injured on the Service Road. "The contradiction of oral testimony [against a written document] is inherent in the very nature of a bill of lading." Jacksonville Paper Co., 317 F.2d

at 1082. Likewise, the credibility of the testimony is irrelevant because there was no contradictory document. Therefore, although there was some contradictory evidence, the district court abused its discretion by denying Green's motion for a new trial on the grounds that "the court fails to have all of the evidence before it" or that "the general verdict was contrary to the evidence and the weight of the evidence." The district court reasoned that "[d]espite the evidence produced by Mr. Green in rebuttal, none of the evidence produced by the defendant directly contradicted the evidence produced by Mr. Green." This was error. B. 20 The district court must consider and balance all the evidence and, if it agrees with the prevailing party that the verdict is not against the weight of the evidence and for good reasons, the court must grant a new trial. See *International Harvester Co. v. Joy Mfg. Co.*, 720 F.2d 1147, 1152 (10th Cir.1983); see also 10A Charles A. Wright et al., *Federal Practice and Procedure* Sec. 2531 (2d ed. 1986) ("[T]he granting or denial of a motion for a new trial is often a discretionary matter and is reviewed under an abuse of discretion standard."
